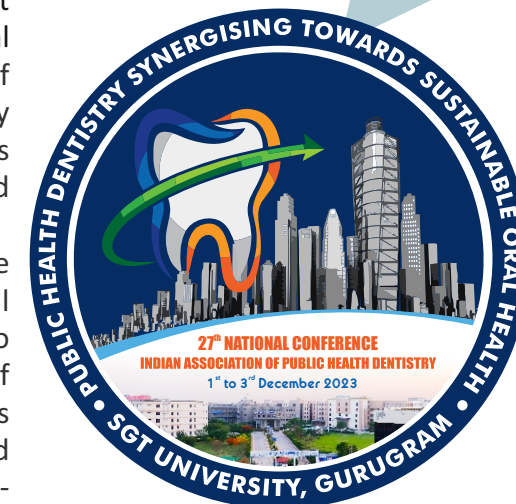
Conference Theme

Public Health Dentistry is a unique area of dentistry that is formed by a marriage of the broad fields of dentistry and public health, with a strong emphasis on prevention of oral diseases and ensuring provision of adequate promotive, preventive and treatment services among individuals.

Despite significant improvements, oral disease is still highly prevalent in all populations, and more importantly, is a disproportionate burden to certain disadvantaged or vulnerable population groups. General Guidelines

1. Abstract submissions will be accepted online in prescribed format through the link available on the conference website.
2. Registration for the 27th IAPHD National Conference is **mandatory** to be eligible for any Scientific Presentation.
3. Scientific Presentations can be submitted under the following categories: -
 - Scientific Paper (Oral Presentation) - Open for Faculty members, Final year, and Second Year PG students
 - Scientific Poster (E-Poster with Oral Presentation) - Open First and Second-year PG students
 - Scientific Poster (Print form) - Open for All faculty and postgraduate students – This category is being kept with the idea to bring back the originality and olden days essence of any Scientific Conference, but it will be reviewed on the basis of interest shown by the presenting delegates.
4. All Scientific papers/Scientific posters can be either **Theme based** or **Non – Theme based**.
5. Theme based Scientific papers/Scientific posters can be submitted under following focus areas:
 - Oral Health Awareness and Education
 - Legislation, Policy, and Advocacy
 - Digital Health and Artificial Intelligence
 - Sustainable Oral Healthcare for Special Groups
 - Inter-sectoral and Multilateral Collaborations
 - Clinical health research
6. A delegate can present as author in only one category of presentation, but can present as co-author in more than one presentation.
7. All postgraduates are required to upload the duly filled consent form (signed by their respective guides) along with the online abstract submission. The format is available for download from the website abstract submission page.

8. All Abstract submissions must be in English language.

9. Authors are responsible for the accuracy of information provided during submission (eg. spellings, designation etc.)

10. Scientific paper /Scientific poster not fitting into any of above focus areas may be submitted as Non-Theme Based Scientific paper/Scientific poster.

11. Reviews (Meta – analysis, Systematic Review, Narrative Review etc.) may be submitted as Theme or Non – Theme-Based Scientific paper/Scientific poster.

12. The focus area should be reflected in either the title or objective of the abstract to enable scientific committee to decide on appropriateness of focus area under which the Scientific Paper/Scientific poster is submitted.

13. The scientific committee will have the sole discretion to accept/decline the paper or change the focus area.

14. Previously published abstracts (in print or any electronic format) or those presented at another meeting are not encouraged and will not be allowed.

15. Acceptance of the abstract is subject to the decision of the scientific committee which would be final and binding.

16. A confirmation email on the receipt and review of the abstract will be sent to the presenting author. The Registration ID will serve as Conference Presentation ID.

17. Following the submission, there will be no opportunity to modify these abstracts and resubmit them for further consideration.

18. All abstracts for Scientific paper/Scientific poster shall be the exclusive property of the Scientific Committee, 27th IAPHD National Conference and may be used for appropriate academic purposes.

19. The delegates are encouraged to submit their abstract ahead of deadline to avoid unforeseen last-minute delays.

20. Awards will be given to the Best Scientific Presentations during the 3 days course of Conference .

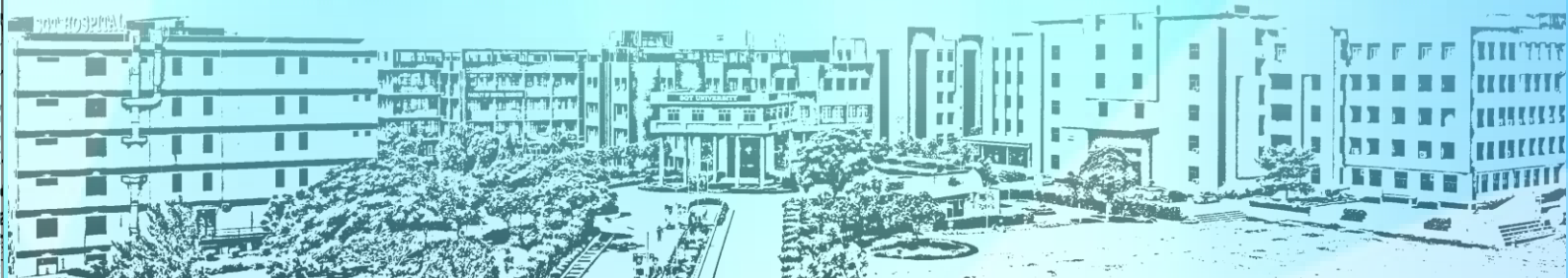
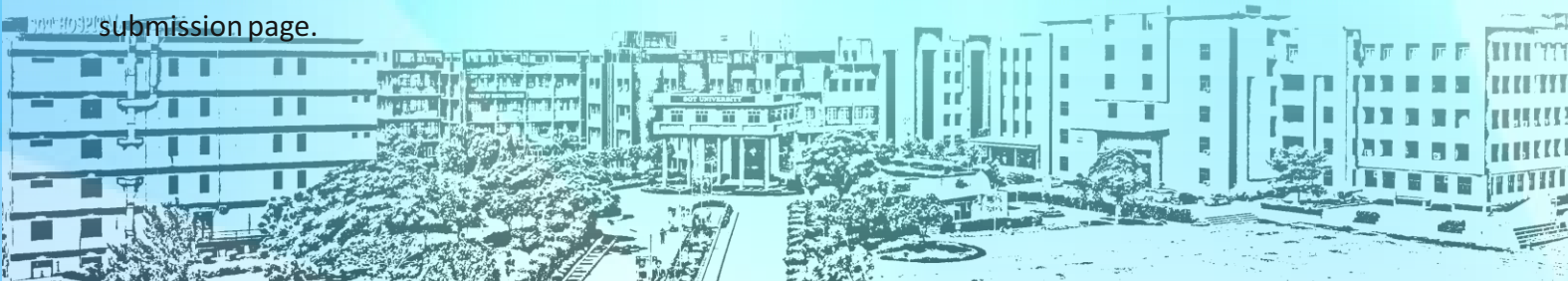

Oral Paper/Poster Abstract - Specific Guidelines

- 1. We encourage you to send an informative abstract (complete abstract) as it will be published in the souvenir.
- 2. It is the authors responsibility to check for completeness, accuracy, and authenticity of the content. Incomplete abstract submission (Example, where it is cited as, “results awaited”) will not be accepted.
- 3. Abstracts should be structured as **Introduction, Objective, Methodology, Results** and **Conclusion** as **applicable for scientific papers and posters and unstructured for general posters**. No tables, graphs or images are allowed in the Abstract Submission.
- 4. Abstracts should contain original material that has neither been published nor presented at another meeting at the time of submission.
- 5. The maximum word limit is **250 words**.

Oral Paper Presentation Specific Guidelines

- 1. The duration for paper will be **8 minutes** followed by **2 minutes** for discussion. Presenting author should strictly adhere to the time schedule.
- 2. All papers are to be presented in a PowerPoint presentation 2003 or higher versions in formats ppt/pptx.
- 3. Presentations should be prepared in the wide screen format with a ratio of 16:9.
- 4. Images, Figures, Video, and Audio will be preferred more over Text in PPT.
- 5. First slide of the Power Point presentation should contain only the Title of Presentation and the Conference Registration ID Number allotted by the Registrations Committee.
- 6. Please use the Power Point Presentation template uploaded by Scientific committee on the website for your presentation (will be uploaded and notified on a later date).

Oral E- Poster Presentation Specific Guidelines

- 1. Presenter needs to attend and be available during poster presentation session on a designated day.
- 2. Duration for E-Poster Presentation will be **5 mins (3 minutes)** for presentation followed by **2 minutes** for discussion/question-answer).
- 3. The posters should be in JPEG/PDF format in Landscape Orientation (ratio of 16:9) and only the Title of Presentation and the Conference Registration ID Number allotted by the Registrations Committee should be displayed.
- 4. Overall File size: Less than 5 MB; Images and tables: at least 300 dpi.
- 5. Good picture quality is essential.

Oral Print Poster Presentation Specific Guidelines

- 1. Presenter needs to attend and be available during poster presentation session on a designated day.
- 2. Duration for Print Poster Presentation will be **5 mins (3 minutes)** for presentation followed by **2 minutes** for discussion/question-answer).
- 3. The Poster must be presented physically and it will be in hardcopy format.
- 4. You are required to arrange your layout of the poster (3ft x 4ft - Portrait) according to the template uploaded by the scientific committee on the conference website and keep the design ready for further instructions (will be uploaded and notified on a later date).
- 5. Good picture quality is essential.

About the City

Gurgaon was historically inhabited by the Hindu people, and in early times it formed a part of an extensive kingdom ruled over by the Ahir clan. In Earlier History is told that it was the Village of Guru Dronacharya who was the Teacher of Kauravas and Pandvas. In 1947, Gurgaon became a part of independent India and fell under the Indian state of Punjab. In 1966, the city came under the administration of Haryana with the creation of the new state.

Gurgaon, officially named Gurugram, is a planned city located in the northern Indian state of Haryana. It is situated near the Delhi-Haryana border, about 30 kilometres southwest of the national capital New Delhi and 268 kmsouth of Chandigarh, the state capital. It is one of the major satellite cities of Delhi and is part of the National Capital Region of India.

Gurgaon is India's second largest information technology hub and third largest financial and banking hub. Gurgaon is also home to India's largest medical tourism industry. Despite being India's 56th largest city in terms of population, Gurgaon is the 8th largest city in the country in terms of total wealth. Gurgaon serves as the headquarters of many of India's largest companies, is home to thousands of startup companies and has local offices for more than 250 Fortune 500 companies. It accounts for almost 70% of the total annual economic investments in Haryana state, which has helped it become a leading hub for high-tech industry in northern India. Gurgaon is categorised as very high on the Human Development Index.
